7. Care Requirements

- Children can only be enrolled for a minimum of two days. Official regulations require that the child must attend a minimum of 4 morning sessions and 2 afternoon sessions in the obligatory kindergarten year.
- Attendance can be made up of a combination of full and half days. For example, 2 days enrolment can be made up as 2 full days, or 1 full day and 2 half days, or 4 half days.
- Half days run from 07h30 to 13h00, and full days from 07h30 to 18h30. Afternoon only half days are
 not possible. Ad hoc arrangements can be made to extend a morning half day to a full day at a cost
 of CHF 100 per half day extension.

8. Other Terms and Conditions

- a. There will be a 2 week settling period. At the end of this period either party to the agreement may terminate the agreement. Any fees paid in advance (excluding the settling in month) will be refunded.
- b. Where fees are in arrear for longer than 1 month, Lifestyle Educare will have the right to terminate this agreement.
- c. Any legal costs incurred to recover outstanding fees will be recoverable from the parents or legal guardian.
- d. Where a child is absent from class, there will be no refund of or making up of days in lieu of days absent
- e. Where the child requires extraordinary care due to illness or is infectious, the child is not to attend school.
- f. Where the child falls ill at school, employees will take all reasonable steps to treat the child or get professional treatment as necessary. In such situations parents should make the necessary arrangements to collect the child when requested to do so.
- g. Accident, health and civil liability insurance in relation to the child will be the responsibility of the parents or legal guardian.
- h. For excursions, activities off the Kita premises, or where a particular situation necessitates it, employees are permitted to transport the child by car or public transport.
- i. This agreement will be governed by Swiss Law.
- j. In the event of any claims or disputes, the Canton where Lifestyle Educare is physically located will have jurisdiction.
